


**Investment Objective**

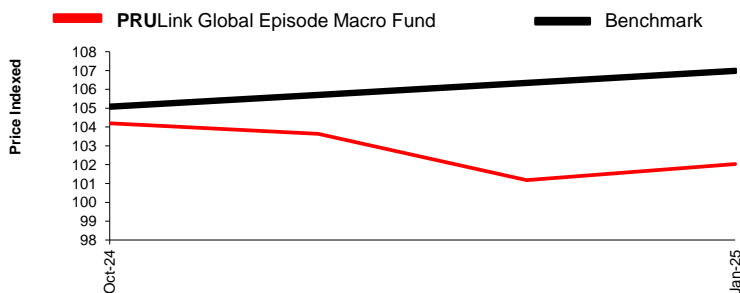

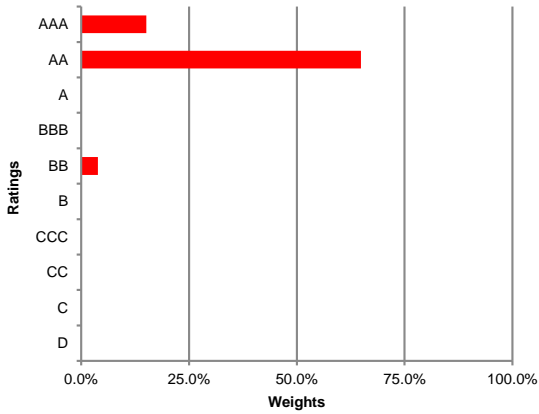

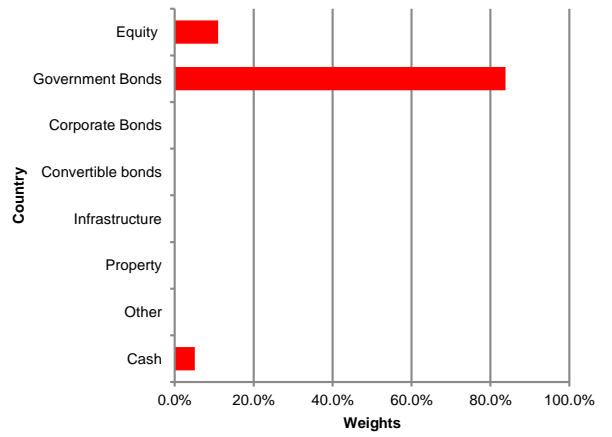

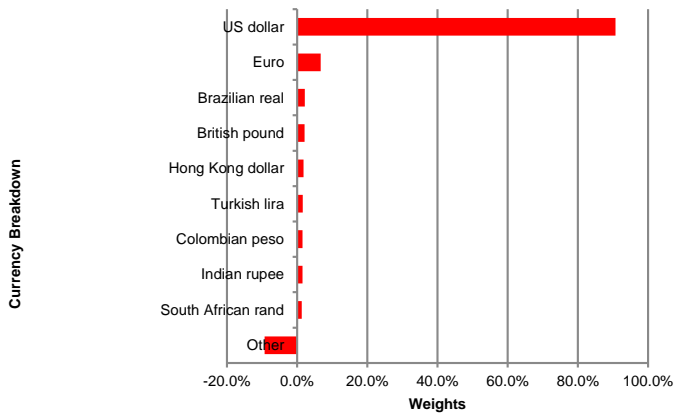
Credit Ratings Breakdown<sup>3</sup>
