The investment objective of PRULink Global Signature CIO Balance Fund is to achieve growth through capital appreciation and income accumulation over a mid to long-term investment horizon.

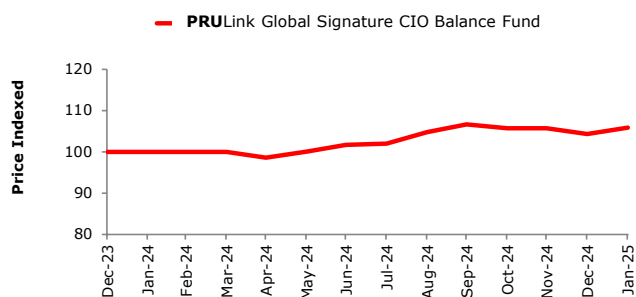

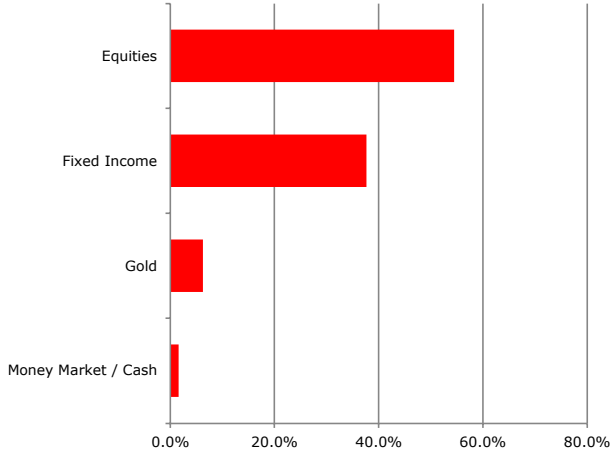
